Ordinance Appropriating \$3,700,000 for the Greenville Loop Trail Section 2 Transportation Bond Project (2TRST21913)

LEGISLATIVE INTENT/PURPOSE:

WHEREAS, this ordinance will appropriate \$3,700,000 in funds from multiple projects and the Bike/Pedestrian Contingency in the Transportation Bond program to supplement the existing funds for the Greenville Loop Trail Section 2 Transportation Bond Project (Project); and,
