## **Ordinance Appropriating \$3,700,000 for the Greenville Loop Trail Section 2 Transportation Bond Project (2TRST21913)**

### **LEGISLATIVE INTENT/PURPOSE:**

WHEREAS, this ordinance will appropriate \$3,700,000 in funds from multiple projects and the Bike/Pedestrian Contingency in the Transportation Bond program to supplement the existing funds for the Greenville Loop Trail Section 2 Transportation Bond Project (Project); and,

WHEREAS, this appropriation will supplement the current Project budget to all for the award of the construction contract, and to provide an appropriate construction contingency for the Project.
