Ordinance Making Supplemental Appropriation of \$237,618 from the North Carolina Parks and Recreation Trust Fund Accessible Parks Grant and \$56,382 from the Public Improvements Fund for the Replacement of the Fit For Fun Center Outdoor Playground

LEGISLATIVE INTENT/PURPOSE:

WHEREAS, the Fit For Fun Center, located at 302 S. 10th Street, is a recreation facility where children ages 0-5 and their families are offered a diverse range of structured activities and programs, and large indoor and outdoor play areas; and,

WHEREAS, Fit For Fun's outdoor playground was installed in 2002, receives a high volume of use, and is not fully ADA accessible; and,

WHEREAS, the City of Wilmington applied for a North Carolina Parks and Recreation Trust Fund Accessible Parks Program Grant, which provides \$12.5 million in matching grants for recreation facilities to benefit people living with disabilities in North Carolina and local governments; and,

WHEREAS, the City of Wilmington received an Accessible Parks Grant in the amount of \$237,618 to support the replacement of the Fit For Fun Center outdoor playground, fencing, and ground surface; and,

WHEREAS, the City of Wilmington's required match of \$56,382 is available in the Public Improvements Fund.

THEREFORE, BE IT ORDAINED:

THAT the following supplemental appropriation is hereby made to the Public Improvements Fund and that the revenues are available to meet this appropriation.
